- Clearly indicate and credit the source of the images concerned when making their submission.
- Provide contact details of the individual, organization or agency from where the images were obtained.
- Confirm the authorization of the source/copyright holder(s) with respect to free use at the discretion of the Fur Free Alliance of the relevant images in the context of the Design Against Fur competition as presented herein – including public exhibition, multi-media presentations, web-posting on the sites of the Fur Free Alliance and/or its affiliated organizations, media releases and coverage – including but not limited to newspaper and magazine articles, newsletters as well as television reports.
- When dealing with images obtained from professional agency sources, an exemption may be entered for commercial use of the images.
- Such an exemption must be clearly indicated on the release form and the potential financial implications may be taken into account by the jury in the judging process.
- Provide any other relevant information regarding the source(s) and/or right(s) pertaining to the artwork/images used.
- Incomplete, misleading and/or fraudulent information regarding ownership of and/or rights to the artwork/images used shall automatically disqualify the student(s) concerned.

The Fur Free Alliance assumes no responsibility for any actions or damages that may accrue from use – including notably commercial use in good faith – of images or artwork which are the object of misrepresentations or incomplete declarations made by students entering the Design Against Fur competition.
